The Early Years of CIV Lodge


Castle Island Virtual Lodge is a Regularly Constituted lodge in the Grand Lodge of Manitoba. Our charter is like that of any other lodge in Manitoba; we have the ability to Open/Close and complete all ritual that could be conducted as within a traditional Manitoba lodge.

Background Information

Castle Island Virtual Lodge was intended to met Virtually on the Internet. The founding members set forth a process to enable Educational meetings for the 5th Wednesday of the month. All meetings are held at 7 pm Central Standard time and conducts all business within the Entered Apprentice degree.

Background Information

However, it should be noted that the lodge can hold a "Traditional" meeting within a Bricks and Mortar lodge. The lodge could be opening in traditional form in any Country at Aminty with the Grand Lodge of Manitoba. This includes all aspects of the Ritual and degree work.

Do hereby complithate the said Brethren into a Lodge of Free and Accepted Masons under the Title or denomination of the

Castle Island Hirtual Codge No. 190

the said Lodge to meet virtually via the Internet format, from the City of Winnipeg, Manitoba on the fifth Wednesday of a month containing five Wednesdays empowering them in the said Lodge when duly congregated, in a Lodge Grom, to make, pass and raise Freemasons according to the Ancient custom of the Eraft in all ages and Nations through the known World. And further at their said polition and of great trust and confidence reposed in all and every of the above named brethren. We do hereby appoint the said David George Love to be the first Worshipful Master, the said Constante (Chibu) Sison Uson to be the first Senior Warden and the said David Wallace (Jake) Molms to be first Junior Warden for opening and holding the said Lodge and until such time as another Master shall be regularly elected and installed, strictly charging that every Member who shall be elected to preside over the said Lodge, and who must previously have duly served as Warden in a Warranted Lodge, shall be installed in ancient form and according of the Laws of the Grand Lodge, that he may therefore be fully invested with the dignity and powers of his Office. And we do require the said 🗗 avid Groupe Love to take special care that all and every of the said Brethren are, or have been, regularly made Masons and that you and they, and all other Members of the said Lodge, do observe, perform and keep the Laws, Rules and Orders contained in the Book of Constitution, and all the others which may from time to time be made by our Grand Lodge or transmitted by us or our Successors, Grand Master or by our Deputy Grand Master for the time being. And we do enjoin you to make such By Zaws for the government of your Lodge, as shall to the majority of Members, appear proper and necessary, the same not being contrary or inconsistent with the General Laws and Regulations of the Eraft a copy whereof you are to transmit to us. And we do require you to cause all such By Laws and Regulations and also an account of the proceedings in your Lodge to be entered in a Book kept for that purpose. And you are in no wise to omit to send to us or our successors, Grand Masters or to our Deputy Grand Master for the time being, in form and manner directed by the Book of Constitution to regularly confirm the Lodge membership of your Lodge and the names and descriptions of all Masons initiated therein and Brethren who shall have joined the same with the fees and monies payable thereon. It being our will and intention that this our Warrant of Constitution shall continue in force so long only as you shall conform to the Laws and Regulations of our Grand Lodge. And you the said David George Love are further required, as soon as conveniently may be, to send to us an account in writing of what shall be done by virtue of these presents.

The name Castle Island originates from our first meeting location which occurred in Second Life VR Platform. In 2012 the Lodge owned a virtual island that had a castle as its virtual meeting room and all of this existed within that virtual world.

Origins of CIV Lodge



Second Life is a free 3D virtual world where users can socialize, connect and create using free voice and text chat. The system was used for two years with limited success; the founding members continued to seek an improved system for online meeting.

Internet Lodge vs A Virtual Lodge




Technology challenges

One of the first challenges we covered was the creation of "WebEx users guide" as well as a "Protocol and Etiquette" within our Virtual lodge. The guide speaks to how to setup the technology of the Video Conference platform - sound, video and bandwidth.






